

- [1] The School Management or School cannot take any type of capitation fee, donation, reserve fund or conduct interview of children by granting admission.
- [2] The School will not deny admission in absence of proof of evidence to any child or will not refuse admission on the ground of religion, caste or race or place of birth or any one reason out of it.
- [3] The School will have to undertake that :
- > Will not detain any child admitted in the school in any class till primary education is completed or will not debar from the class or school.
 - > Will not make physical punishment or mental torture to any child.
 - > The child will not have to appear examination of any Board till primary education is completed.
 - > Will issue certificate to each student completing primary education.
 - > Will appoint the teachers possessing qualifications as provided in Bombay Primary Education Act, 1947 and Bombay Primary Education Rules, 1949 only.
 - > Any teacher of the school will not participate in any activity related to private tuition.
- [4] The syllabus prescribed by the Competent Educational Authority of the State Government will have to be taught.

- [5] The number of students will have to be admitted as per infrastructural facility available with the school for accommodation.
- [6] Any unrecognized classes will not be run in the school, or the school will not run unrecognized classes under the same name at other place.
- [7] The building, ground or other infrastructural facilities of the school will be used only for developing education and skill. The School will be run only by the society constituted under Society Registration Act, 1860 or any other Act.
- [8] The School will not be run for profitable object by any individual or society or society of individuals or other individuals.
- [9] The financial accounts of School will have to be got audited from Chartered Accountant and will have to obtain his certificate and get certified necessary statement and a copy of the same will have to be sent to concerned District Education officer.
- [10] The School will have to provide information sought by District Education officer, State Government or Local Institutions from time to time in respect of adherence of terms and conditions of recognition or removing its lacunas.
- [11] If the above terms and conditions will not be followed, the recognition of School will be cancelled.

- [12] The standards and merits prescribed for schools under section 19 and 25 of Right of Children to Free and Compulsory Education Act -2009 of the Government of India will have to be maintained.
- [13] As per the provision of section 12[c] of Right of Children to Free and Compulsory Education Act -2009, the admission to minimum 25% of weaker and deprived class children will have to be reserved.
- [14] The recognized school will have to maintain students- teachers ratio mentioned in Education Department Resolution PRE/142010-242076-K dtd.3/6/2010.
- [15] As per the provision of section 18[5] of Right of Children to Free and Compulsory Education Act -2009 of the Government of India, if any individual establishes or runs a school without obtaining recognition certificate or continues to run after withdrawal of recognition, he will be penalized upto Rupees One Lac, and in the matter of continuing breach, penalty upto Rupees Ten Thousand can be imposed for each day during which such breach continues.
- [16] The teachers recruited in the school must be trained in addition to facilities in classes run in the school for addition of class.
- [17] If the school will not be started by you in the year of permission at the place mentioned, the permission will become liable to be cancelled automatically.
